Statewide Associate Membership and Membership Conditions

A vendor of products or services to long term care operators may join CAHF as an associate member with this stipulation: If you/your company **owns, operates, manages or controls** one or more long-term care facilities, then you must join as a **facility member**. If you wish to also be an associate member, that is your choice - but if you are involved in operating one or more facilities, the CAHF Bylaws require facility membership for all those facilities, and **associate membership may not be held in lieu of (as a substitute for) facility membership.**

Benefits include access to CAHF's professional staff, chapter participation and member prices. Associate membership is authorized by the CAHF Bylaws and granted under rules and regulations adopted by CAHF's Board of Directors.

Membership Dues

When applying for membership, annual dues are payable in full or by credit card payment plan installments. Associates who join after July 1st pay \$600.00 prorated dues to cover the remainder of the year. Both full-year and mid-year memberships expire on Dec. 31 each year and prompt renewal ensures your free directory and website listings.
